



# Hospitality

Music sets the mood in your bar or restaurant. Music attracts visitors who dance, have fun and spend money. Research shows that music boosts sales and sets the tone for any occasion. You pay composers and songwriters a fee to use this music.

# How we calculate the fees

We calculate the fees based on the number of square metres of your business where music can be heard. This could include an outdoor terrace.

For entertainment music, we base this on surface area and number of days. The artist fee/buy-out fee amount may not exceed € 1,000 per performance and the entrance fee may not exceed € 25.

## Please note

- If you play the same music in different rooms, we add up the total number of square meters of the rooms.
- If you play different music in different rooms, you pay separately per room.
- Different tariffs apply to music used at events or films. Please ask us for the applicable tariff overview.
