



# Mechanical Background Music

## WHAT DOES THIS TARIFF COVER?

Any form of background music played through sound equipment, unless a Special Background Music Tariff applies. For an explanation of terms, please check the tariff conditions.

# How we calculate the fees

We calculate the fee based on the number of square metres of your business or venue where your visitors can hear the music. The area is easy to calculate. If music can also be heard outside, then we calculate the exterior area by multiplying the length of in front of your facade by 3. If you play the same music outside as inside, you only pay 50% for outdoor use.

We have two categories for this. The function of the music and the level of visitor numbers and flow will determine which category applies to you. See reverse for an overview.

Please contact us if you are not sure which one your organisation falls under or if it is not clear how to calculate the surface area

## Please note!

- In addition to an annual agreement, seasonal agreements are also possible.
- If you play the same music in different rooms, we add up the total number of square metres of the rooms.
- If you play different music in different rooms, you pay separately per room.
- Different tariffs apply to music used in the hospitality industry, workplaces and other specific locations. Please ask us for the applicable tariff overview or visit [mijnlicentie.nl](http://mijnlicentie.nl).

## \*\* Category B:

shops (excluding self-service shops, supermarkets and department stores), fancy fairs, exhibitions, stands, natural ice rinks, showrooms, video shops, sports grounds, stadiums (not ice rinks) and sports halls, sports areas without catering facilities, aircraft, trains, buses, waiting areas without catering facilities, swimming pools and saunas, petrol stations, car parks.
