



# Central Transmission Tariff for Healthcare Institutions 2024

The Central Transmission Tariff for Healthcare Institutions applies to music use transmitted within healthcare institutions, as well as the provision of TV/radio facilities to patients. For the explanation of some terms, please refer to the tariff conditions.

# The Tariff

The cost is based on the number of beds where there is a connection to the transmitted signals.

The price per bed is € 6.89.

The price is exclusive of VAT.

## Tariff conditions Central Transmission Tariff for Healthcare Institutions

### 1. Definitions

**Transmission:** The distribution of music-carrying signals for the benefit of individual patients, regardless of the technique used to transmit the signal.

**Music use:** the public performance of music belonging to the repertoire managed by Buma.

**Healthcare:** the activities of medical professionals, including examining, diagnosing or treating, nursing or caring for a person with diseases or injuries.

**Healthcare institution:** an organisation providing healthcare.

### 2. General Terms and Conditions

Buma's General Terms and Conditions and what is stipulated in the applicable tariff including tariff conditions apply to the agreements and requests for agreements between Buma and music users and any agreements and obligations arising therefrom. They are available for inspection at Buma and will be sent on request.

### 3. Scope of application

The Central Transmission Tariff for Healthcare Institutions applies to music use in the form of transmission within healthcare institutions.

### 4. Special rate

- a. The Central Transmission Tariff for Healthcare Institutions is a Special Central Transmission Tariff as referred to in article 4(a) of the tariff conditions of the Central Transmission Tariff.
- b. The Central Transmission Tariff for HealthCare Institutions is a Special Tariff as referred to in Article 4 of the General Tariff conditions for music use.

## 5. Obtaining permission

Voor het Muziekgebruik vermeld in dit tarief kunnen muziekgebruikers de auteursrechtelijke toestemming van Buma verkrijgen door met Buma een overeenkomst te sluiten voor één of meer uitvoeringen.

## 6. Surcharge for retrospective settlement

The prices for the mentioned music use only apply if an agreement has been reached in advance with Buma for the use of music. If a music user does not enter into an agreement, Buma may charge a surcharge of 50% of the price applicable to the music use in question, with a minimum of € 25. Buma is not obliged to grant retrospective permission.
